Dear Lady Perrott,

I attach herewith the particulars of voluntary hospitals offered in this locality, which the Military Authorities do not appear to make use of.

I know that the officer commanding the 1st Northern General Hospital wishes to evacuate some of his cases, and some have been sent to civil hospitals, but as I have pointed out to the Military Authorities, there is a grave danger in evacuating in this manner, because most of the civil hospitals are entirely kept up by the classes, and if the civil hospitals are full, accidents in civil life will not be admitted, and as it is known that we have volunteered our temporary hospitals for military cases, there will be a reaction against the ways of the War Office.

The ladies who have formed these hospitals have gone to a great deal of trouble, and apparently all their efforts are in vain, and I fear that if once dismantled, as they will have to be very soon, there will be such indignation felt that they will never be available again.

I hope that you will be able to put these views before the War Office.

I believe that the Deputy Director of Medical Services, Northern Command, has submitted some of them to the War Office for sanction in connection with the 1st Northern General Hospital.

Dear Sir,

I have some 500 garments (shirts, bedjackets, belt, socks, pillows, etc.,) made by the women in my village, which I am anxious to send to a base hospital. May I ask for your kind assistance to enable me to do this? If you will be so good as to let me know to whom, and where, the consignment should be addressed and through whom it should be despatched I shall feel extremely grateful.

I have also an empty house in a very salubrious situation in the village, standing amongst the hills at an altitude of about 600 feet, with a southern aspect, which I am anxious to furnish and prepare for the reception of 15 or 20 wounded soldiers. It occurs to me that there may be some printed instructions which would be very

valuable to anyone undertaking this work. If you could send me a copy, or kindly tell me where I can obtain the necessary information, I shall be still further obliged. I know you must be inundated with letters, and, therefore, apologise for troubling you.

With reference to your letter of the 19th October asking for return of garments made. I may point out to you that you have had a list only about a week ago and it entails an enormous amount of work preparing these lists. Mrs Palmer is in charge of the Depot and responsible for everything. Would you kindly write to her in future respecting the Depot.

I think I should inform you that the Lord Mayor of Newcastle has got together a very large committee of ladies as a working party. They have sent in a considerable quantity of garments to our Depot, but they object to these garments going outside of No. 6 District, as they think they should be used for general hospitals and for voluntary hospitals when required. Our first St John Voluntary Hospital is accepted at Whinny House, Gateshead, and wounded will be sent to it this week tomorrow without fail. This is an 80 bed hospital, and complete in itself.

With reference to your letter about Brancepeth Castle the position is that Lord Boyne is providing 30 beds, and the County Durham VAD another 30 beds. Lord Boyne supplies all servants and feeds them and the Nursing Staff. We supply a St John, VAD as staff.

The First Northern General Hospital will pay at the rate of 2/- per day per head for

patients.

The officer commanding the First Northern General Hospital is now not troubling to

go to the War Office about places he has taken and is doing it all through me.

We have now the following St John Hospitals in use.

Whinny House, Gateshead – 80 beds

Jeffrey Memorial Hall Sunderland – 40 beds

German Seamen's Home, South Shields – 50 beds

17 South Bailey, Durham – 30 beds

Report on the VA Hospitals in the County of Durham

The following hospitals have been established and St John Detachments mobilised to staff six Hospitals in this county.

No. 1 Durham VA Hospital Whinney House, Gateshead

Consists of 55 beds. Has been established since October 23rd, and 142 patients have been under treatment at this hospital. 50 members of St John VAD have carried out the entire duties. These have been drawn from detachments at Felling, Heworth, Gateshead and Saltwell. The Matron is Lady District Superintendent, Mrs CB Palmer.

No. 2 Durham VA Hospital Mill Dam, South Shields

Consists of 50 beds. Has been established since August 31st. 70 patients have been treated at this hospital up to November 3rd. This does not include out-patients (ie wounded home on furlough). 22 members from VA Detachments of South Shields and Tynemouth have carried out entire duties. The matron in charge is Mrs JR Crease.

No. 4 Durham VA Hospital Jeffrey Memorial Hall, Sunderland

Consists of 32 beds. Has been established since August 10th. Total patients treated 55. No. of members 32 taken from Sunderland VAD. Commandant of the hospital is Dr IG Modlin.

No. 5 Durham VA Hospital 17 North Bailey, Durham

Consists of 30 beds. Established November 1st. Patients treated up to November 30th – 30. Number of members – 17 drawn from Durham City VAD. Matron in charge – Mrs Wykesmith.

No. 7 Durham VA Hospital Brancepeth Castle, Co. Durham

63 beds equipped. Patients – 23. Hospital commenced December 3rd. No. of members 8, drawn from Gosforth (Northumberland) Division, VAD. Matron in charge – Mrs Bean.

The Rest Station at the Central Station, Newcastle, which has been entirely under the charge of the nursing sisters of the St John Ambulance Brigade has treated 1674 cases. These members are constantly on duty to the extent of three at a time.

West Hartlepool Temporary Hospital

This is a hospital established at West Hartlepool to attend to the troops of the garrison, but is run in the same way as other hospitals in the county, with the exception that the sick and wounded from overseas are not sent into it. The West Hartlepool Division has entirely staffed this hospital. The number of cases has been considerable (no particulars yet).

Other St John Hospitals in the counties of Northumberland and Durham will be occupied when more sick and wounded are sent to the North of England, at the: 'Richard Murray' Hospital, Blackhill.

Dear Lady Perrott,

Mrs Vasey, Lady Superintendent and Commander of Houghton le Spring Nursing Division and VAD is a perfect nuisance to me and to everyone else.

She may be visiting you about Houghton Hall being accepted as a hospital. If she

does, I hope you will refer her to me.

The place is suitable but as County Director, I cannot recommend the place as Mrs Vasey is impossible. She has got the whole of the locality in arms against her. I got letters from all sorts of people complaining. She is doing us a lot of harm in consequence. I have had to [snub] her and reprimand her constantly. She put a committee together for collection of goods and quarrelled with them all. She wants to hoard goods up for a possible hospital and I ask that the goods should be put to

some use. This the Committee want to do.

At present no more hospitals are wanted up here as existing ones are half empty.

County of Durham:

No. 1 Durham VA Hospital

Whinney House, Gateshead, for sick and wounded overseas, and as auxiliary to the 1st Northern General Hospital. 85 beds, 282 patients treated since first occupied 23rd October 1914.

No. 2 Durham VA Hospital

Mill Dam South Shields, for Overseas and Garrison cases. 50 beds, 272 patients since first occupied, 31st August 1914.

No. 4 Durham VA Hospital

Jeffrey Memorial Hall Sunderland, for Overseas and Garrison cases. 32 beds, 161 patients since first occupied 10th August 1914.

No. 5 Durham VA Hospital

17 North Bailey Durham, for Overseas and Garrison cases. 30 beds, 67 patients since first occupied. 1st December 1914.

No. 7 Durham VA Hospital

Brancepeth Castle, for Overseas cases. 60 beds, 174 cases since first opened, December 3rd 1914.

No. 8 Durham VA Hospital

Masonic Hall, West Hartlepool for Garrison cases. 25, beds, 286 patients since first opened 11th. August 1914. On the occasion of the Bombardment of the Hartlepools 35 bed cases, and 100 out patients were treated.

No. 9 Durham VA Hospital

Chilton Moor Fence Houses, for Garrison Cases. 18 beds, 38 patients have been treated since first occupied, January 23rd 1915.

No. 10 Durham VA Hospital

3 Clervaux Terrace, Jarrow for Garrison sick. 17 beds, 32 patients sincefirst occupied 19th. January 1915.

No. 11. Durham VA Hospital

Social Centre Sunderland for Overseas and Garrison cases. 26 beds, 77 cases treated since first opened 19th November 1914.

No. 12 Durham VA Hospital

Richard Murray Hospital Blackhill for Overseas cases. 48, beds, 29 cases treated since first opened January 20th 1915.

No. 13 Durham VA Hospital

Vane House, Dawdon, Seaham Harbour for Garrison sick, 10 beds, 20 patients treated since first opened February 7th 1915.

Northumberland:

No. 5 Northumberland VA Hospital

Percy Gardens Tynemouth for Garrison cases, 36 beds, 72 cases treated since first opened January 20th 1915.

No. 7 Northumberland VA Hospital

Jesmond Road, Newcastle, for Territorial cases, 33 beds. First opened January 20th 1914.

Rest Station

The Rest Station at the Newcastle Railway Station which has been staffed by St John VAD since the commencement of the war, and where two or three members have been in constant attendance, was by order of the Assistant Director of Medical

Services closed on February 5th. The reason being that local hospitals and detention

stations at all ports where troops are quartered have now been provided.

A total of 2223 have been treated in the Rest Station. A very large number of

vaccination sores were dressed, minor accidents were attended to, one death took

place and one birth took place in the Rest Station.

Transport

The Hon. Sir Charles Parson KCB presented a motor ambulance to the St JAB. This

is under charge of the Newcastle Division and is in constant use for military

purposes.

At Sunderland the transport of all wounded men from hospital trains to the infirmary

and Voluntary Aid Hospitals is carried out entirely by the St JAB.

Depots

The Cambridge Hall Depot has sent out 15,060 articles up to March 1st 1915, and

has received 24,065.

Whitby Division (St JAB)

This division has done exceptionally meritorious work in connection with the rescue

of the crew of the Hospital Ship 'Rohilla'. Although a new division the work of the

men was beyond praise, and has received the warmest thanks from the Admiralty

Authorities.

Again on the occasion of the bombardment of Whitby, the division rendered most

valuable service to the town in rendering First Aid to wounded persons.

West Hartlepool Nursing Division

This division which is working as a VAD rendered notable service on the occasion of

the bombardment.

The detachment was under shell fire, the hospital being struck on several occasions. 35 serious cases were brought in and 100 out patients were treated. Great credit is due to the Commandant Mrs MA Strover.

Durham 60 has not I believe obtained the grant. The Commandant received a county grant from me of £10 which she is probably confusing with that from the Order.

Durham 42 and 64 have not received grants. Does the secretary of the Order not give you information?

Northumberland 88. It is noted that the application has been made for this grant.

In addition to these the following VAD have now been mobilised and have equipped hospitals and should receive grants viz:

Northumberland 54 and Durham 84.

As regards the former. This VAD is completely equipping a large hospital for local sick soldiers. It is a working class detachment without large funds, and if it could be possible to receive the grant I think it should be done.
