26 February 1915

Dear Lady Perrott,

A hospital will be opened at the Richard Murray Hospital, Blackhill, in conjunction with Shotley House, Shotley Bridge, both under St John, and for this the DDMS [Deputy Director Medical Services] Northern Command has promised a convoy of 100 patients direct from Southampton, provided that we can find a surgeon to take charge of the hospital. Sir Frederick Treves some time ago promised me a surgeon, but we were not then able to open the hospital, and I have a letter in response now for a surgeon from Sir Frederick Treves, informing me that he has not a single surgeon available. I do not know whether you can help in any way; I should be obliged if you could. If I should be able to secure a surgeon locally, in the event of your not having one, will the Joint War Committee be prepared to pay his salary? Yours faithfully,
